#### **EXECUTIVE DIRECTOR'S REPORT:**

**NJCE MEMBERSHIP – OCEAN COUNTY:** We are pleased to announce that Ocean County joined the Fund effective June 1, 2014 as the NJCE's 9<sup>th</sup> member. We welcome Ocean County to the Fund, Freeholder John P. Kelly has been appointed as Commissioner and County Administrator Carl Block as Alternate Commissioner.

**2014 BUDGET AMENDMENT:** Enclosed in the agenda was a copy of the current overall budget and by member. Executive Director said the addition of Ocean County to the program represents a 5.19% increase to the budget. In accordance with the local regulations, it would be appropriate to amend the budget via a public hearing utilizing the teleconference system based on Commissioner's availability and/or in conjunction with the Camden Insurance Commission July 24, 2014 meeting. The Board discussed and agreed to schedule a public meeting on July 24, 2014 at 1:30PM to amend the budget.

# MOTION TO INTRODUCE ON FIRST READING THE AMENDMENTS TO THE 2014 BUDGET AND TO SCHEDULE THE PUBLIC HEARING ON JULY 24, 2014 AT 1:30PM AT THE CAMDEN COUNTY REGIONAL EMERGENCY TRAINING CENTER:

The fund office will advertise the public hearing with the fund's official newspapers, as well as, post it on the NJCE website.

**DECEMBER 31, 2013 AUDIT:** Copies of the <u>draft</u> financial audit for the period ending December 31, 2013 and the Actuarial Valuation as of December 31, 2013 were distributed for review. Fund Auditor said the audit is almost complete, but there are a few items to complete to produce a final report. Fund Auditor reviewed the statements of the NJCE JIF Audit as of December 31, 2013 and said there were no comments or recommendations. Fund Auditor said he does not expect any changes to be made to the final report. Executive Director said it would be appropriate for the Board to direct the fund office to file the draft audit and seek an extension from the Department of Community Affairs. Enclosed in the agenda was Resolution 20-14 authorizing this action.

**MARKETING REPORT:** Enclosed in the agenda was a report from Frank Proctor updating the new business activities for the CELJIF. The report indicated that the underwriting data for Atlantic County is currently being obtained and reviewed to provide quotes for a 1/1/15 membership date. Executive Director reported that initial meetings are being set up with Bergen and Monmouth counties, as well as other southern counties that have expressed interest in the fund.

**PROPERTY PROGRAM** – **CATASTROPHE MODELING:** Executive Director said with the growth in the membership, our property insurance limits, particularly the \$135 million per occurrence named storm limit, is spread over a larger insured value/risk then in earlier years. The insurance industry has developed modeling programs to estimate the amount of loss to a particular peril such as wind, fire or earthquake. This so called "CAT Model" is based on the actual location data from each insured together with construction and exposure information. The output is a series of estimates called Probable Maximum Loss (PML) for the peril being measured.

Executive Director said there are a limited number of firms offering this analysis and it is in the range of \$15,000 to \$20,000 depending on the size of the database being analyzed. We ask for a motion authorizing PERMA to prepare and release an RFP with the assistance of the Fund Attorney. Members of the Board did not object to a study/CAT Model and agreed with the recommendation to prepare an RFP for these services.

#### THIRD PARTY CLAIMS (TPA) ADMINISTRATOR

**NAME CHANGE:** Enclosed in the agenda was a notice from CompServices who will now be doing business as AmeriHealth Casualty Services as of May 19<sup>th</sup>. Enclosed was Resolution 22-14 amending the contract to reflect the name change.

**RFP:** As previously reported, the fund's contract with CompServices will expire on 8/1/14. The fund office advertised the RFP for a TPA Claims Administrator and received responses from two vendors, Amerihealth Casualty Services and Inservco Insurance Services, Inc. Executive Director said it would be appropriate to discuss the responses during Closed Session. Enclosed in the agenda was Resolution 24-14 authorizing the need for Closed Session.

**ACTUARY:** As previously reported, the fund's contract with The Actuarial Advantage will expire on 6/30/14. The fund office issued a Request for Price Quotes was advertised and was sent to three firms to provide a response. The Actuarial Advantage was the only firm to respond and their complete response was included in Appendix II of the agenda. In response to the Fund Attorney's inquiry, Ms. Ghani Fund Assistant Secretary confirmed that the price quote request was sent to three different vendors for a response and only one firm, The Actuarial Advantage, responded. In addition, the price quote was advertised in all of the fund's official newspapers.

Enclosed in the agenda was Resolution 23-14 appointing The Actuarial Advantage as Fund Actuary based on their submitted quote.

**FINANCIAL DISCLOSURES:** The fund office has provided all Fund Commissioners with the PIN they need to complete their Financial Disclosure filing for the NJCE JIF. The deadline for filing was June 13<sup>th</sup>. All but five commissioners have filed their disclosure forms and reminders have been sent to file.

**CLAIMS STATUS SUMMARY:** AmeriHealth Casualty Services prepared a summary report of any claims with large open reserves to be reviewed during Closed Session. Enclosed in the agenda was Resolution 25-14 authorizing the need for closed session.

**NJCE WEBSITE:** The fund's website, <u>www.njce.org</u>, continues to be updated on an as-needed basis with fund information.

**FINANCIALS:** Executive Director referred to the Financial Fast Track as of May 31, 2014 and said the Fund's current surplus of \$4.1 million.

#### **UNDERWRITING MANAGER:**

**2014 RISK MANAGEMENT PLAN:** Included in the agenda as part of the Underwriting Manager's report was a revised Risk Management Plan reflecting the addition of Ocean County to the program, the change to a three insurer quota for the excess property and a name change for the Gloucester County College. The Risk Management Plan was included in the agenda as Resolution 26-14.

**2014 EXCESS COVERAGE OCEAN COUNTY:** The Extraordinary Unspecifiable Services (EUS) statements for Ocean County were included in the agenda as part of the Underwriting Manager's report and enclosed was Resolution 21-14 memorializing the purchase of insurances.
