APPROVAL OF MINUTES FROM SEPTEMBER 25, 2014 AS PRESENTED:

EXECUTIVE DIRECTOR'S REPORT:

2015 BUDGET: Enclosed in the agenda was the 2015 Proposed Budget presentation for review and discussion. Executive Director said the proposed 2015 budget is increasing by 2.5% over last year for a total of \$19,964,592. The following was noted with respect to the budget:

- Loss Funds Fund Actuary projected total loss funds of \$3,835,569 represent a 6% decrease from last year based on fund's positive experience to date.
- Premiums Underwriting Manager reported negotiations are being finalized with the fund's excess carriers and the total premiums represented in the proposed budget will be on/or about target for budget adoption. The projected and approximate premiums for property are increasing by 4.8%, liability by 5%, workers' compensation \$500,000 excess of \$500,000 layer by 9% and the Statutory excess of \$1,000,000 by 8.6%. Executive Director said a phase-in allocation method to move workers compensation premiums by member closer to their respective payroll allocation is being developed.
- Expenses Executive Director reported the 2% increases in professional fees are budgeted figures only as the Board confirms appointments and compensation at the February annual reorganization meeting.
- Ancillary Coverages Underwriting Manager said the ancillary coverages are being confirmed with all members for renewal. Due to the recent growth of the NJCE, some monies have been budgeted to allow for the potential purchase of higher flood aggregate limit.

In response to Commissioner Albert, Executive Director said the impending sale of Runnells Hospital would affect the workers' compensation premium of their assessment since it is based on payroll. Seeing no other questions or comments Executive Director requested a motion to introduce the 2015 budget and schedule a public hearing.

Executive Director said the property premiums are generated by applying the property rate against the total values as reported by each entity. Executive Director said he welcomes individual feedback from the board should there be any questions or comments before the next meeting.

NEW COMMISSION MEMBERSHIP REVIEW – COUNTY OF ATLANTIC: The fund office has completed reviewing the County of Atlantic as a potential new member. A full report and presentation will be presented at the meeting during Closed Session for review and discussion. Once the review is complete, enclosed in the agenda was Resolution 37-14 to offer membership to the County of Atlantic.

CLAIMS STATUS SUMMARY: AmeriHealth Casualty Services prepared a brief summary report of all claims with large open reserves to be reviewed during Closed Session. Enclosed in the agenda was Resolution 36-14 authorizing the need for closed session.

NJCE WEBSITE: The fund's website, <u>www.njce.org</u>, continues to be updated on an as-needed basis with fund information.

FINANCIALS: Executive Director referred to the Financial Fast Track as of August 31, 2014 and said the fund's currently statutory surplus is \$4.8 million.
