EXECUTIVE DIRECTOR REPORT:

2018 BUDGET: A sub-committee comprised of Commissioners White and Mecouch met telephonically on October 23, 2017 to review the preliminary 2018 budget.

Enclosed in the agenda was the budget totaling \$21,700,119 or an increase of 2.9% over last year. Executive Director provided a summary of the budget comparing 2017 annualized against proposed 2018 figures was provided as follows:

- Claims Loss Funds Fund Actuary provided flat projections to the claims loss funding for Liability, Auto and Workers' Compensation.
- Excess Insurance Premiums overall 3.9% increase based on submitted underwriting data. Executive Director said the budget reflects self-insured retentions (SIR) as expiring and includes a property premium buffer. Executive Director said lengthy discussion was held on whether the property SIRs at the local member level should be increased based on loss experience or whether the NJCE should retain the risk.
- Expenses overall 1.9% increase with a 2% budgeted increase to professional and contractual fees. Executive Director said the budget included Underwriting Data Validation, which was built into the 2017 budget to reflect a progressive initiative to obtain consistent and ratable data through payroll audits, property appraisals and an underwriting data system.
- Ancillary Coverage the NJCE acts as a pass through for these optional coverages, which are elected by members on an annual basis.

Underwriting Manager said negotiations were underway to place coverages with carriers noting that National Casualty and Wesco have decided to leave the public entity market. Underwriting Manager said Zurich, the Fund's property carrier, would like to increase the SIRs based on large value losses; however, continued discussions are being held to offer options. Commissioner White said the discussion at the preliminary budget meeting was good and the consensus was that any increase to SIRs would need to occur over time. Committee requested the Underwriting Manager review higher retentions and present at the next meeting if available.

DIVIDEND: Executive Director said the sub-committee also reviewed available dividend options and the recommendation is to release a total dividend of \$200,000 out of balances from Fund Years

2010 and 2011. Enclosed in the agenda was a worksheet on the allowable dividends per State Regulations at the last audit of 12/31/16, as well as, resolution 37-17 authorizing the release of a dividend. Executive Director said the Fund authorized the release of a dividend in the amount of \$150,000 for the past two years. Executive Director said based on the Fund's strong financials, the dividend for release could be increased to \$200,000.

PROFESSIONAL CONTRACTS – **ACTUARY:** Executive Director said the Fund's contract with The Actuarial Advantage will expire on November 16, 2017. Executive Director said the fund office would issue a request for price quotes and report the responses received at the next available meeting.

CLAIMS STATUS SUMMARY: AmeriHealth Casualty Services has advised there are no Payment or Settlement Authority Requests to review and as such no need for Closed Session.

MEMBERSHIP RENEWAL: The Counties of Atlantic, Burlington, Cumberland and Salem are scheduled to renew their membership with the Fund as of January 1, 2018. To date, renewal documents have been received from the Counties of Atlantic and Burlington.

JOINT INSURANCE CLAIMS COMMITTEES BEST PRACTICES WORKSHOP: The 6th annual Joint Insurance Claims Committees Best Practices Workshop is scheduled for Wednesday, November 1, 2017 and will focus on *Cyber Liability – Coverage, Risk Management and Available Resources*. The workshop will be held at Conner Strong & Buckelew office in Marlton, NJ; interested participants may also attend the workshop at our Parsippany and Toms River offices.

FINANCIAL FAST TRACK: Executive Director reviewed the Financial Fast Track as of August 31, 2017 and said the Fund's statutory surplus is \$7.6 million.
